Expression of Interest for Installation of Air Conditioner Plant



Notice Inviting Expression of Interest for Installation of Air Conditioning Plant for the Library Section of the Sahitya Akademi Part-I

The Sahitya Akademi, an autonomous institution under Ministry of Culture, Government of India, New Delhi invites Expression of Interest for Installation of Air Conditioning Plant in the Library Section of the Sahitya Akademi. The last date for submission of interest is within 10 days from 09th February, 2016.

The air conditioning plant will have to be installed by the Authorized Supplier/Manufacturer on award of contract for supply and installation or as decided by the competent authority and those interested vendor who fulfill the minimum criteria need submit their interest. The party whose tender/quotation is accepted/found to be lowest shall also be liable to dismantle the present air conditioning plant on Buy Back Basis.

The Akademi reserves the rights to amend/ withdraw any terms and conditions of the expression of interest document or to reject any or all expressions without giving any notice or assigning any reason. In this regard, the decision of the Competent Authority in Sahitya Akademi shall be final and binding on all.

The interested vendor will be bound by the details furnished by it while submitting the interest. In case any of such documents furnished by it is found to be false at any stage, it would be deemed to be a breach of terms of contract making it liable for legal action besides termination of contract.

The applicant shall bear cost of preparation and submission of EOI. Applicant must deposit the EOI fees of Rs.500/- (Rupees Five Hundred only) in the form of bank draft in favour of "Secretary, Sahitya Akademi, New Delhi". The EOI not accompanied by the requisite fee is liable to be summarily rejected.

The applicants need to provide all the reference details/documentary evidences required to fulfill the eligibility criteria as applicable.

The EOI should be in the prescribed format. Any EOI not found responsive to the details mentioned in this document liable to be rejected. The EOI will be opened in the office of the Secretary, Sahitya Akademi, Rabindra Bhavan, New Delhi on 24th February, 2016 at 02.30PM. The venders who have submitted their EOI may attend or depute their authorized representative.

The applicant is requested to review the response before submission as the submitted response shall be considered final and revisions may not be permitted, unless there are genuine reasons for such revision.

The parties through respective signatories shall settle any dispute or disagreement with respect to performance, non-performance or defective performance of respective obligation amicably. In the event of disputes remaining unresolved, the parties shall refer the matter to a single arbitrator under arbitration law that may be applicable, whose appointment shall be done by Secretary, Sahitya Akademi. The place of arbitration shall be New Delhi and the language used shall be English.

The Earnest Money equivalent to 2% to 5% in the form of an account payee Demand Draft in favour of Secretary, Sahitya Akademi, New Delhi shall be submitted alongwith Technical Bid.

The earnest money of unsuccessful applicants will be returned within reasonable time. However, the Sahitya Akademi shall neither be responsible for any loss nor liable to pay interest thereon for the period the Earnest Money while in its possession.

Tender placed in a sealed cover with the name of the project "<u>Tender for Airconditioning</u> <u>of the Library Section of the Sahitya Akademi</u>"</u> written on the top which shall contain two envelopes viz. TECHINICAL BID (Envelope-I) and Financial BID (Envelope-II) with the



name of the project written on each envelope. The tender addressed to Secretary, Sahitya Akademi, Rabindra Bhavan, 35, Ferozeshah Road, New Delhi – 110001 will be notified separately or informed on the day of opening of EOI.

The Technical Bid shall be opened on (to be notified separately or informed on the day of opening of EOI) in the presence of the tenderer or their authorized representatives at the Sahitya Akademi Conference Hall on the 3rd Floor of the Rabindra Bhavan. The technical bids shall be scrutinized by the committee constituted for the purpose. The Committee shall assess the ability of the agencies to carry out the requisite work with regard to their profile and experience in the field.

The Financial bid of only those venders would be opened who are found technically qualified. The date and time of opening of Financial Bids will be decided during opening of the Technical Bids.

The venders should quote in figures as well as in the words the rates and amount tendered by them in the financial bid. The rates quoted in the financial bid shall be inclusive of all taxes, levies etc. except service tax which shall be as applicable from time to time. Nothing extra shall be payable over and above the accepted rate as per the price schedule mentioned in the Financial Bid.

The successful vendor will enter into an agreement with the Sahitya Akademi for supply/installation/maintenance of the air conditioning plant within warranty/guarantee period as and when required. **The party shall also be liable to dismantle the present air conditioning plant on Buy Back Basis**.

The successful bidder would have to deposit a performance guarantee equivalent to 10% of the value of the contract in the form of DD in favour of Secretary, Sahitya Akademi, New Delhi within 5 days from the date of issue of the work order. The earnest money shall be adjusted against the performance security to be submitted by the successful bidder. The performance security can be forfeited by order of the competent authority in the Sahitya Akademi in the event of any breach or negligence or non-observance of any condition of contract or for unsatisfactory performance or non-observation of any condition of contract. On expiry of the contract, such portion of the said performance guarantee sufficient to cover any incorrect or excess payments made on the bills to the firm shall be retained until the final audit report on the account of firm's bill has been received and examined as may be considered by the competent authority in the Sahitya Akademi.

No advance payments will be made. Payment of the total contract amount will be made by electronic transfer on successful completion of work duly certified by the Committee constituted for the purpose.
